2.1 ANSI/TIA-568.0-E-1 (Addendum 1 Single Balanced Twisted-Pair Use Cases and Topology):

TR-42.1 unanimously agreed to defer action on TIA-568.0-E-1 until the next meeting in October as it has a dependency on another unpublished standard (TIA-568.5).

2.2 ANSI/TIA-758-C (OSP): 3rd Industry Ballot

The 3rd industry ballot for TIA-758-C has not yet been issued. Henry Franc is completing changes resulting from the comment resolution on the 2nd industry ballot.

2.3 ANSI/TIA-862-C (Intelligent Building Systems):

- Ray Emplit led ballot comment resolution on ANSI/TIA-862-C.
- Resolved comments were posted as TR421- 2021-06-011a
- TR-42.1 unanimously agreed to issue ANSI/TIA-862-C for a default ballot

2.4 ANSI/TIA-942-B-1 (Edge Data Centers):

- Jonathan Jew led ballot comment resolution on ANSI/TIA-942-B-1.
- Resolved comments were posted as TR421- 2021-06-010a
- TR-42.1 unanimously agreed to issue ANSI/TIA-942-B-1 for a 1st industry ballot

2.5 ANSI/TIA-4966-A (Education): 1st Industry Ballot

Diane Forbes reported that she is completing changes resulting from the comment resolution on the 1st industry ballot.

3.1 ANSI/TIA-942-C (Data Centers):

- Reviewed PAR for ANSI/TIA-942-C (TR421-2021-06-012)
- The motion to accept the PAR was approved. (Approved: 16 Opposed: 2)
- PAR will be submitted to TIA once meeting report has been approved by TIA legal.



- Jonathan Jew, of J&M Consultants, volunteered to be the editor

3.2 ANSI/TIA-1179-A (Health Care):

- The subcommittee created a PAR (TR421-2021-06-013) to open and revise the existing ANSI/TIA-1179-A standard to develop ANSI/TIA-1179-B.
- The motion to accept the PAR to open and revise ANSI/TIA-1179-A was approved. (Approved: 14 Opposed: 0)
- PAR will be submitted to TIA once meeting report has been approved by TIA legal.
- Dave Kozischek, of Corning, volunteered to be the editor

3.3 ANSI/TIA 4994 (Standard for Sustainable ICT):

- TIA was not able to get any data on usage internally or from IHS Global
- After discussion within the subcommittee about the lack of any communication or questions related to the standard, and with no data to support that it is a standard purchased and used, the subcommittee felt that it was not worth updating or reaffirming.
- The subcommittee created a PAR (TR421-2021-06-014) to withdraw the ANSI/TIA-4994 standard
- The motion to accept the PAR to withdraw ANSI/TIA-4994 was approved. (Approved: 11 Opposed: 1)

3.4 ANSI/TIA-5017 (Security):

- The subcommittee created a PAR (TR421-2021-06-015) to open and revise the existing ANSI/TIA-5017 standard to develop ANSI/TIA-5017-A.
- The motion to accept the PAR to open and revise ANSI/TIA-5017 was approved. (Approved: 11 Opposed: 0)
- PAR will be submitted to TIA once meeting report has been approved by TIA legal.
- TR-42.1 is looking for someone to volunteer to be the editor

3.5 TIA-TSB-185 (MICE):

- The subcommittee discussed whether TIA-TSB-185 should be opened and updated or reaffirmed.
- No one present in the subcommittee meeting was able to confirm that nothing has changed in the 11803 standards document that the original values came from. Therefore, a decision about what to do is deferred to the October meeting. Brad Woodman will compare the values in both documents and bring a recommendation to the October meeting about whether updates or no changes are needed.
- The subcommittee will review Brad's recommendations at the October meeting and then create a PAR to either open the TSB to revise or reaffirm it.



3.6 TIA-TSB-5018 (DAS):

- The subcommittee discussed next steps for TIA-TSB-5018 since it was last published in 2016.
- Diane Forbes suggested creating a DAS standard out of the TSB. The subcommittee members were not sure if there is sufficient content in the TSB to create a standard. Members would like to review the TSB before deciding on next steps.
- The subcommittee will request a copy of TIA-TSB-5018 to be made available to TR42.1 members.
- Decision about next steps (new standard, open and revise TSB, reaffirm TSB) will be made at the October meeting and the appropriate PAR will be created.

3.7 TIA-TSB-5046 (Sustainability for Manufacturers)

- TIA was not able to get any data on usage internally or from IHS Global
- After discussion within the subcommittee about the lack of use members have seen, and with no data to support that it is a standard purchased and used, the subcommittee felt that it was not worth updating or reaffirming.
- The subcommittee created a PAR (TR421-2021-06-016) to withdraw the ANSI/TIA-5046 standard
- The motion to accept the PAR to withdraw ANSI/TIA-5046 passed without opposition. (Approved: 12 Opposed: 0)

3.8 Other new business:

There was no other new business.

Henry Franc mentioned that TIA was doing a survey to determine if members would like to have an in-person meeting for the first meeting of 2022. The survey was closing on the next day (6/16).

Contributions affecting a document are to include a TIA cover sheet, proposed text to be included in the document, and the rationale/substantiation for the contribution. All contributions shall be submitted to the electronic document coordinator (EDC). All electronic files shall be provided in either Adobe Acrobat (*.PDF); Microsoft Word (*.DOC); Microsoft PowerPoint (*.PPT); or in Microsoft Excel(*.XLS). Compressed files shall be accessible using PKUNZIP or WINZIP (*.ZIP).

Early submittal and posting of contributions for consideration in meetings is highly encouraged. Contributions shall be submitted to the EDC as soon as possible and then posted to the appropriate TIA Connect folders by the EDC as soon after receipt as possible, preferably within one business day. All contributions shall be posted to the appropriate location on TIA Connect no later than 12:00 noon EST on the Monday preceding the week of the meeting in which the contribution is to be considered (example: if the meeting will be held on Thursday the 20th, the contributions shall be posted by noon on Monday the 10th).

LATE CONTRIBUTIONS:
