### 2.2. Subcommittee reports and plenary action

#### 2.2.1. TR-42.1 – Premises Telecommunications Infrastructure

Diane Forbes presented TR42-2023-01-031.

Cindy Montstream of Legrand was elected Chair and Diane Forbes of NIS was elected Vice-Chair of TR-42.1.

TR-42.1 resolved industry ballot comments and approved publication for TIA-568.1-E-1 (Commercial Buildings, Addendum 1): It includes single pair and additional wireless access point cabling guidance.

TR-42.1 resolved industry ballot comments and approved publication for TIA-4966 (Education Addendum 1). It adds single pair guidance.

TR-42.1 resolved industry ballot comments for ANSI/TIA-758-C (*Customer-Owned Outside Plant*) and approved a default ballot.

TR-42.1 resolved industry ballot comments for ANSI/TIA-1179-A (*Health Care*) and approved a default ballot.

TR-42.1 reviewed the first draft of TIA-570-E (Residential Revision) and approved a 1st industry ballot.

TR-42.1 resolved 1<sup>st</sup> industry ballot comments to TIA-942-C (*Data Center Telecommunications Infrastructure*) and approved the 2<sup>nd</sup> industry ballot.

TR-42.1 partially resolved 1<sup>st</sup> committee ballot comments to ANSI/TIA-5017-A (Security) and will continue comment resolution at an interim meeting.

TR-42.1 discussed the revision to the TIA-568.0 application tables suggested by IEEE 802.3 and decided to create a project request in the June Meeting for a TSB with the application tables.

TR-42.1 discussed the consolidation of 568.0, 568.1, and 862. Ray Emplit will provide two outlines, one each for two approaches to consolidate the documents.

TR-42.1 discussed and rejected a motion to split the edge data center content from TIA-942.

#### 2.2.2. TR-42.3 – Telecommunications Administration, Pathways, Bonding and Grounding

Cindy Montstream presented TR42-2023-01-032.

Cindy Montstream of Legrand was re-elected Chair and Jonathan Jew of J&M Consultants was re-elected Vice-Chair of TR-42.3.

TR-42.3 approved project requests for ANSI/TIA-569-F and ANSI/TIA-607-E with Ray Emplit as editor for both documents.

TR-42.5 reviewed new definitions, new acronyms, and modifications to existing definitions.

TR-42.7 resolved ballot comments to ANSI/TIA-568.5 addendum 1 (*corrections to TIA-568-5 single-pair cabling*) and authorized the 3<sup>rd</sup> industry ballot. Added some items to it based on the results of the '184' ballot.

There were no comments on the default ballot of ANSI/TIA-1183-B, *balun-less measurement methods*. TR-42.7 authorized publication.

TR-42.7 reviewed contributions on single-pair multi-drop.

TR-42.7 authorized a 1<sup>st</sup> industry ballot for ANSI/TIA-568.2-E with Sean Lenz as editor.

TR-42.7 deferred until June the decision on TSB-190 (shared sheath), withdraw, revise, or re-affirm.

TR-42.7 acknowledged the contributions of Cameron Jones.

Phil Irwin of Panduit was re-elected as Chair and Tiger Ninomiya of Senko was elected Vice-Chair of TR-42.11.

TR-42.11 reviewed fiber optic standards with focus on Broadband Equity, Access, and Deployment (BEAD) Program, PON, and Outside Plant.

### 2.2.7. TR-42.12 – Optical Fibers and Cables

David Kozischek presented TR42-2023-01-037.

ANSI/TIA-492CAAC *Singlemode* (adopt with modifications of the IEC 60793-2-50:2018) was published Jan 21, 2022 including all amendments and changes through Errata

TIA-455-133-A (05/2003) is an adoption of the IEC 60793-1-22:2001 *Optical fibres - Part 1-22: Measurement methods and test procedures - Length measurement* has no action until IEC 60793-1-22 is published.

TIA-455-111-B (FOTP-111): adoption of IEC 60793-1-34 (*Measurement methods and test procedures – fibre curl*) was published (approval at a previous meeting)

ANSI/TIA-4920000-C adaption (adopt with modifications) of IEC 60793-2:2019

TR-42.12 approved TIA-455-3-C (FOTP-3) *Temperature Ramps and Precision* for publication at the previous meeting, but it requires editing before publication.

TR-42.12 will resolve comments to ANSI/TIA-4920000-C *Generic* adaption (adopt with modifications) of IEC 60793-2:2019 at the next TR-42.12 meeting as the committee ballot closes on April 3.

TIA-455-133-A (05/2003) adoption of the IEC 60793-1-22:2001 *Optical fibres - Part 1-22: Measurement methods and test procedures - Length measurement* has no action until IEC 60793-1-22 is published.

TIA-455-203-A (03/2009) FOTP-203 *Light Source Encircled Flux Measurement Method*): plan to adopt the IEC 61280-1-4 *Fibre Optic Communication Subsystem Test Procedures - Part 1-4: General Communication Subsystems - Light Source Encircled Flux Measurement Method* has no action until IEC 61280-1-4 is published in 2023.

TIA-455-204-A (10/2013) adoption of the IEC 60793-1-41:2010 *Optical fibres Part 1-41: Measurement methods and test procedures – Bandwidth* has no action until IEC 60793-1-41 is published in 2024.

TR-42.12 approved a ballot for TIA-455-3 (FOTP-3) *Temperature Ramps and Precision* with approval to publish if there are no technical no comments.

TR-42 approved a ballot of ANSI/TIA 492AAAF *Multimode* (adopt with modifications of IEC 60793-2-10:2019).
