1. Call to Order:

The Chair called the meeting to order at approximately 14:20 Eastern Time (Charlotte local time) and volunteered to act as secretary. The Chair indicated that all relevant documents are on the TR-8.5 FTP site.

2. Record of Attendance:

Participants were advised to record their attendance with TIA staff and a summary of the attendance is provided later in this report. A quorum was established with 12 of 13 eligible voting organizations present.

3. Review and Approve Agenda:

The Chair noted that the meeting agenda had been distributed by TIA prior to the meeting and that it is available as 19-017. The Chair then called the participants' attention to the TIA Participation Notice and Important Notice for Participation (see above) and asked for a motion to accept the October meeting agenda. Dwight Smith moved, and Chris Maiers seconded, a motion to accept the October meeting agenda as written. The motion passed unanimously by voice vote.

4. Review and Approve Last Meeting Report:

The Chair noted that the previous meeting report had been distributed by TIA prior to the meeting and that it is available as 19-016. The Chair then asked for a motion to accept the June meeting report. Dwight Smith moved, and John Lambrou seconded, a motion to accept the June meeting report as written. The motion passed unanimously by voice vote.

5. TIA IPR Policy:

The Chair called the participants' attention to Note 2 on the meeting agenda for information regarding the TIA IPR Policy (see above) that was read to the participants earlier in the day. The Chair asked the question "is there knowledge of patents, the use of which may be essential to any document being considered during this meeting that anyone would like to disclose at this time"? There was no new IPR identified.

6. Old Business:

The Chair called the participants' attention to 19-020 for a summary of the subcommittee activities since the previous meeting. The Chair then called the participants' attention to slide 2, and noted that no conference calls were held since the June meeting.

a. Disposition of ANSI/TIA-PN-102.BAIB-B Tier 1 Location Services Specification:

The Chair called the participants' attention to slide 3 and indicated that the TIA assigned project number for the 3rd Edition is ANSI/TIA-PN-102.BAIB-B and that Motorola Solutions is the document editor. The Chair also indicated that the purpose of the project is to address the comments recorded in comment matrix 19-002-R2. The Chair then indicated that the latest documents are in the "Tier 1 Location Service" subfolder.

The Chair indicated that the Revision B-v2 draft proposal 19-012-R1 was approved for ballot during the June quorum meeting. The Chair also indicated that the ballot was issued August 5th and closed September 19th. The Chair then indicated that the ballot summary report 19-018 was distributed September 25th and that the ballot was successful with no ballot comments. The Chair asked if there was a motion from the floor to publish the Revision B-v2 draft proposal.

Dwight Smith moved, and John Lambrou seconded, a motion to publish contribution 19-012-R1, Revision B-v2 draft proposal for the Tier 1 Location Services Specification 3rd Edition, as TIA-102.BAIB-B with "Project 25" on the cover page if the Project 25 Steering Committee approves the document as part of the Project 25 Standard; if the Project 25 Steering Committee does not respond in the affirmative within 20 business days, the document will be published without "Project 25" on the cover page. The motion passed unanimously by voice vote. The Chair took an assignment to prepare contribution 19-012-R1 for publication and to submit a Publication Authorization form to the TIA Standards Department to publish the document after allowing time for the Project 25 Steering Committee to determine the disposition of the document.

b. Disposition of ANSI/TIA-PN-102.BAEB-C IP Data Bearer Service Specification:

The Chair called the participants' attention to slide 4 and indicated that the TIA assigned project number for the 4th Edition is ANSI/TIA-PN-102.BAEB-C and that Motorola Solutions is the document editor. The Chair also indicated that the purpose of the project is to address the comments recorded in comment matrix 19-004-R2. The Chair then indicated that the latest documents are in the "IP Data Bearer Service" subfolder.

The Chair indicated that the Revision C-v1 draft proposal 19-013 was approved for ballot during the June quorum meeting. The Chair also indicated that the ballot was issued August 5th and closed September 19th. The Chair then indicated that the ballot summary report 19-019 was distributed September 25th and that the ballot was successful with no ballot comments. The Chair asked if there was a motion from the floor to publish the Revision C-v1 draft proposal.

Dwight Smith moved, and John Lambrou seconded, a motion to publish contribution 19-013, Revision C-v1 draft proposal for the IP Data Bearer Service Specification 4th Edition, as TIA-102.BAEB-C with "Project 25" on the cover page if the Project 25 Steering Committee approves the document as part of the Project 25 Standard; if the Project 25 Steering Committee does not respond in the affirmative within 20 business days, the document will be published without "Project 25" on the cover page. The motion passed unanimously by voice vote. The Chair took an assignment to prepare contribution 19-013 for publication and to submit a Publication Authorization form to the TIA Standards Department to publish the document after allowing time for the Project 25 Steering Committee to determine the disposition of the document.

c. Work Summary:

The Chair called the participants' attention to slide 5 for a summary of current and future work items for the subcommittee and provided a brief statement regarding each one.

The Chair provided a brief summary of the following documents:

- Tier 1 Location Services Specification 3rd Edition – approved for publication
- IP Data Service Specification 4th Edition – approved for publication

The Chair indicated that the following documents are due for ANSI 5-year review in 2020:

- TIA-102.BAEA-C Data Overview and Specification (published December 2015)
- TIA-102.BAEE-C Radio Management Protocols (published December 2015)

The Chair proposed a comment period closing June 5th for each document using comment templates 19-021 and 19-022 respectively.

The Chair then called the participants' attention to slides 6 and 7 for a summary of the TIA-102, TIA-902, and EDACS documents published by this subcommittee. The Chair indicated that this content is provided for informational purposes.

7. New Business:

The Chair asked if there was any new business to bring before the TR-8.5 subcommittee. None was offered.

8. Review of Current Assignments:

The Chair is to submit an Existing Project Request form to the TIA Standards Department for revision of project number ANSI/TIA-PN-102.BAJB-A, Tier 1 Location Services Specification. [Complete]

The Chair is to submit a Ballot Authorization form to the TIA Standards Department to issue Ballot ANSI/TIA-102.BAJB-B for the Tier 1 Location Services Specification Revision B-v2 draft proposal 19-012-R1. [Complete]

The Chair is to submit an Existing Project Request form to the TIA Standards Department for revision of project number ANSI/TIA-PN-102.BAEB-B, IP Data Bearer Service Specification. [Complete]

The Chair is to submit a Ballot Authorization form to the TIA Standards Department to issue Ballot ANSI/TIA-102.BAEB-C for the IP Data Bearer Service Specification Revision C-v1 draft proposal 19-013. [Complete]

The Chair is to submit a Publication Authorization form to the TIA Standards Department to publish contribution 19-012-R1 as TIA-102.BAJB-B Tier 1 Location Services Specification after allowing time for the Project 25 Steering Committee to determine the disposition of the document. [New]

The Chair is to submit a Publication Authorization form to the TIA Standards Department to publish contribution 19-013 as TIA-102.BAEB-C IP Data Bearer Service Specification after allowing time for the Project 25 Steering Committee to determine the disposition of the document. [New]
