Arlington VA. (December 21, 2018) – The Telecommunications Industry Association (TIA) TR-45 Engineering Committee on Mobile and Point-to-Point Communications Standards has issued a call for interest for document J-STD-025-A initially titled "Lawfully Authorized Electronic Surveillance". TR-45 is developing guidelines in the area defined by the following scope: "This document defines the interfaces between a telecommunications service provider (TSP) and a law enforcement agency (LEA) to assist the LEA in conducting lawfully authorized electronic surveillance."

The stakeholders may include, but are not limited to: Manufacturers and Users of Law Enforcement Equipment.

TIA is actively seeking participation in these projects from the user and general interest communities.
