2.1. Harmonization between TR-14 & TR-42.3 (TR423-2020-10-018)

Cindy Montstream presented TR423-2020-10-018:

The subcommittee agree unanimously to initiate work on an addendum to TIA-607-D to include the changes required to harmonize the work done by TR-14 and TR-42.3.

The subcommittee reviewed and unanimously approved the PAR for TIA-607-D Addendum 1 with content to harmonize the work done by TR-14 and TR-42.3. The revised PAR was posted as 2020-10-019a. Ray Emplit will develop the draft of the addendum for the February meeting, with an industry ballot to occur after that meeting.

2.2. Update on status of ISO/IEC 18598 AMD 1

Jonathan Jew gave an oral report regarding the status of ISO/IEC 14763-2 and ISO/IEC 18598 Amendment 1

Comments to Amendment 1 regarding administration of remote powering to ISO/IEC 18598 (Automated infrastructure management (AIM) systems – Requirements, exchange and applications) were resolved at the virtual ISO/IEC JTC 1 SC 25 WG 3 meeting in on Sept 22. The FDAM (Final Draft Amendment) should be ready for review and editorial comments only in November. TR-42.3 plans to initiate an adoption of the amendment.

The subcommittee reviewed and unanimously approved the PAR for ISO/IEC 18598-1. The revised PAR was posted as 2020-10-016a. ISO/IEC 18598 Amendment 1 will be reviewed at the February meeting with the ballot to adopt it occurring after that meeting.

All electronic files shall be provided in either Adobe Acrobat (*.PDF); Microsoft Word (*.DOC); Microsoft PowerPoint (*.PPT); or in Microsoft Excel(*.XLS). Compressed files shall be accessible using PKUNZIP or WINZIP (*.ZIP).

Early submittal and posting of contributions for consideration in meetings is highly encouraged. Contributions shall be submitted to the EDC as soon as possible and then posted to the FTP folders by the EDC as soon after receipt as possible, preferably within one business day. Notification of the posting shall be made to the group's email reflector list by the EDC within one working day of the posting.
