  - TR-42.1 passed a motion, without opposition, to do an Industry Ballot.
- 2.8 Updating Application Tables in ANSI/TIA-568.0-E (Generic Telecommunications Cabling for Customer Premises)
  - As a result of actions from the October 2022 meeting, Wayne Larsen, liaison from TIA to IEEE, requested that IEEE recommend changes needed to application tables in ANSI/TIA-568.0 by way of a liaison letter. These tables contain information about supporting IEEE applications.
  - George Zimmerman reviewed a contribution summarizing the suggestions from IEEE (TR42-2023-01-005), in response to the liaison letter. He also provided a detailed markup of the tables showing the changes suggested (TR42-2023-01-004).
  - George Zimmerman suggested that TIA reach out to other organizations, like Fibre Channel, to include and/or update application support information.
  - There was also other discussion about moving the tables out of ANSI/TIA-568.0 and into a TSB to make it easier and faster to update the information more frequently. There was support but a final vote was not taken. The committee agreed to review a draft TSB at the June meeting and take a final vote then.
  - Dave Kozischek volunteered to work with George to update the fiber applications' information. Ray Emplit also volunteered to assist with the updates. They will bring a draft for an Applications Tables TSB that will be reviewed at the June meeting. TR-42.1 will then vote on whether to permanently move the application information into a TSB, from ANSI/TIA-568.0, as shown in the draft.
  - Wayne Larsen will provide a PAR for the TSB to approve the project if the committee approves moving forward with the TSB.



#### **2.9** Discuss consolidation of 568.0, 568.1 and 862 standards

- Ray Emplit discussed his contribution on the consolidation of 568.0, 568.1 & 862 (TR421-2023-01-009).
- Ray will put together two outlines for the June meeting. The first outline will show
  what content would be included if ANSI/TIA-568.0 and ANSI/TIA-568.1 is combined.
  The second outline will show what content would be included if ANSI/TIA-862 is
  combined with ANSI/TIA-568.0 and ANSI/TIA-568.1 so that all three standards would
  be combined into one.
