2 Old business

2.1 ANSI/TIA-568.0-E-1 (Addendum 1 Single Balanced Twisted-Pair Use Cases and Topology):

TR-42.1 unanimously agreed to defer action on TIA-568.0-E-1 until the next meeting in January 2022, as it is dependent on another unpublished standard (TIA-568.5).

2.2 ANSI/TIA-758-C (OSP):

The 3rd industry ballot for TIA-758-C has not yet been issued.

Henry Franc provided an update on the status and raised the issue of reference to the TIA-590 standard. Because the 590 standard is old and much of the information is already in ANSI/TIA-758, Henry suggested adding all relevant information from TIA-590 into ANSI/TIA-758. There will also be an editor's note indicating that the text came from TIA-590.

TR-42.1 unanimously agreed to Henry's suggestions.

TR-42.1 will notify TR-42.11 that the intent is to incorporate relevant information from TIA-590 into ANSI-TIA-758 and eventually recommend rescinding TIA-590. A request will be submitted to TIA for a read-only copy of TIA-590 for the TR-42.1 committee.

2.3 ANSI/TIA-862-C (Intelligent Building Systems):

Ray Emplit provided an update on the default ballot. The ballot had 100% approval with no comments.

The committee voted to publish but defer publication until TIA-568.5 has been completed since this document has multiple references to TIA-568.5. (Approve: 14 Reject: 1)

2.4 ANSI/TIA-942-B-1 (Edge Data Centers):

Jonathan Jew led ballot comment resolution on ANSI/TIA-942-B-1. Resolved comments were posted as (TR421- 2021-10-022a).

TR-42.1 unanimously agreed to issue ANSI/TIA-942-B-1 for a default ballot.

2.5 ANSI/TIA-4966-A (Education):

Ray Emplit, the new editor, led ballot comment resolution on ANSI/TIA-4966-A. Resolved comments were posted as (TR421- 2021-10-023a).

TR-42.1 unanimously agreed to issue ANSI/TIA-4966-A for a default ballot.

3 New Business

3.1 ANSI/TIA-568.0-E (Generic Telecommunications Cabling for Customer Premises)

Ray Emplit reviewed the TIA-568.0-E Errata Draft (TR421-2021-10-026). The errata is to fix several errors in Table 10 that were carried over from revision D. The two corrections are to fix the acceleration unit, so the exponent isn't shown as a negative 2, and change the reference from "note *b*)" to "note 2".

TR42.1 voted to approve errata & publish without objection.

3.2 ANSI/TIA-942-C (Data Centers):

Jonathan Jew, of J&M Consultants, is the editor. The PAR has been approved.

This document is on hold until TIA-942-B-1 is completed.

3.3 ANSI/TIA-1179-A (Health Care):

Dave Kozischek/Corning, the editor of 1179-A, reviewed his contribution (TR421-2021-10-024) on suggested changes to the 1179 standard. After discussion, Dave stated that he will prepare a draft for 1179-A with minor changes (updated references, etc.) and submit for ballot.

Dave will submit his suggested changes and additions as comments during the balloting process.

TR-42.1 unanimously approved a committee ballot for ANSI/TIA-1179-A.

3.3 ANSI/TIA 4994 (Standard for Sustainable ICT):

The ANSI PINS was submitted, and the comment period ended on August 15th.

TIA will inform ANSI of the withdrawal of TIA-4994. No ballot is required.

3.5 ANSI/TIA-5017 (Security):

Thar Meepegama is the editor for this document. The Chair, Diane Forbes, gave an update that Thar is in the process of preparing the document draft for ballot.

TR-42.1 unanimously approved a committee ballot for ANSI/TIA-5017.



3.6 TIA-TSB-185 (MICE):

Brad Woodman provided a verbal update that there have been no changes in the MICE tables that would require changes to TSB-185. Brad recommended to reaffirm the TSB.

TR-42.1 unanimously approved reaffirming the TSB.

Cindy Montstream will submit the Status Change Request Form (TR421-2021-10-025) to reaffirm the TSB.

3.7 TIA-TSB-5018 (DAS):

The subcommittee discussed next steps for TIA-TSB-5018 since it was last published in 2016.

After discussion of different options, the TR-42.1 subcommittee unanimously approved reaffirming the TSB-5018.

Cindy Montstream will submit the Status Change Request Form (TR421-2021-10-027) to reaffirm the TSB.

3.8 TIA-TSB-5046 (Sustainability for Manufacturers)

Cindy Montstream submitted the Status Change Request Form to withdraw TSB-5046. TIA will update the covers and send to HIS. No ballot is required.

3.8 Other new business:

There was no other new business.

Compressed files shall be accessible using PKUNZIP or WINZIP (*.ZIP).

Early submittal and posting of contributions for consideration in meetings is highly encouraged. Contributions shall be submitted to the EDC as soon as possible and then posted to the appropriate TIA Connect folders by the EDC as soon after receipt as possible, preferably within one business day. All contributions shall be posted to the appropriate location on TIA Connect no later than 12:00 noon EST on the Monday preceding the week of the meeting in which the contribution is to be considered (example: if the meeting will be held on Thursday the 20th, the contributions shall be posted by noon on Monday the 10th).

LATE CONTRIBUTIONS:
