#### 1. Call to Order.

The Chair called the meeting to order at 1317 local time and recorded the meeting notes.

#### 2. Record of Attendance.

A list of attendees is attached. As a result of the roll call, a quorum was determined to be present. The attendees were advised of the Important Notice of Participation which was included the Meeting Notice/Agenda. The Chair also advised the attendees that TIA is actively seeking participation in projects from the user and general interest communities.

#### 3. Review and Approve Agenda.

The agenda was distributed prior to this meeting, also available on the TIA server as TR-8.10 Meeting Notice\_Agenda.pdf. Dwight Smith moved to approve the agenda, and Jim Eastwood seconded the motion. The motion was approved unanimously by voice vote.

#### 4. Review and Approve Last Meeting Report.

TIA published the last TR-8.10 Meeting Report also available on the meeting server as TR-8.10\_Meeting\_2019\_06\_18\_Meeting\_Report.pdf. Dwight Smith moved to approve the Meeting Report, and Chris Maiers seconded the motion. The motion was approved unanimously by voice vote.

#### 5. TIA IPR Policy.

The Chair asked if there was knowledge of patents, the use of which may be essential to any document being considered during this meeting that anyone would like to disclose at this time. No new IPR was identified.

#### 6. Old Business

The Chair referred the attendance to the file numbered 19-10-013 TR8.10 Oct2019 Status Review.

#### a. Disposition of ANSI/TIA-102.AABA-C "Trunking Overview" revision.

The Chair reviewed progress regarding this revision effort. The ballot was successfully completed on September 19, the details available in the Ballot summary (19-10-014). One editorial comment was submitted and resolved; the draft document 19-05-005 was updated to a R1 version to reflect the editorial comment. James Downes moved to publish 19-05-005-R1 with "Project 25" on the cover page if the Project 25 Steering Committee approves the document as part of the Project 25 Standard; if the Project 25 Steering Committee does not respond in the affirmative within 20 business days, the document will be published without "Project 25" on the cover page. Chris Maiers seconded. The motion passed unanimously by voice vote.

#### b. Disposition of ANSI/TIA-102.AABB-C "Trunking Control Channel Formats" revision.

The Chair reviewed progress regarding this revision effort. The current comment matrix is at version R2. The Chair stated that this content is expected to be impacted by the ongoing Link Layer Encryption (LLE) efforts. This document will remain in drafting as the LLE work makes progress.

#### c. Disposition of TSB-102-D "Project 25 TIA-102 Documentation Suite Overview" revision.

The Chair reviewed progress regarding this revision effort. This draft was distributed for review in August, comments were requested by October 1. The R1 version of 19-06-012 draft addresses two formatting comments; no substantive comments or feedback was received since the August distribution. Dwight Smith moved and Jerry Drobka seconded the motion to open a ballot for the draft 19-06-012-R1 (if approved, to be published as TSB-102-D). The motion passed unanimously by voice vote.

#### d. Disposition of 19-08-008 AABC-E-1\_DRAFT.

The Chair stated this effort started as New Business during the Des Moines meeting. This effort proposes a more flexible use of the abbreviated format of the Status Update Request message. A 45-day review period on the original proposal was completed after which a draft addendum was distributed for comment on August 13; comments requested by September 10. One comment has been received. Jerry Drobka stated comment resolution is in progress. James Downes moved and Jerry Drobka seconded the motion to open a project for the draft 19-08-008 addendum work (if approved, to be published as ANSI/TIA-102.AABC-E-1). The motion passed unanimously by voice vote.

No other old business was offered.

#### 7. New Business.

No other New Business was identified.

#### 8. Review of Current Assignments.

- a. Start the publication process for 19-05-005-R1 (if approved, to be published as ANSI/TIA-102.AABA-C);
- b. Start ballot authorization for TSB-102-D draft.
- c. Open a new project for 19-08-008 (if approved, to be published as ANSI/TIA-102.AABC-E-1).

#### 9. Schedule of Next Meeting.

The next face-to-face meeting will occur sometime during Q1 2020. The Chair requested 30 minutes of meeting time.
